Beginning in 2019, we will produce a summer-focused season, in rotating repertory, with additional programming in the shoulder seasons. This model allows us to realize a healthy earned revenue ratio, enjoy appropriate staffing, offer more paying work to more artists, achieve a larger economic impact on our region, and provide more high-quality, professional theatre to more residents and visitors in our community. To reach this goal, Parallel 45 launched season 8 during this period—a series of performance events with fundraising and audience development goals to make the new operational model possible.
