In 2018-19 Parallel 45 Theatre built on the success of our first 8 seasons to engage more audience, produce more theatre, employ more artists, and have a greater impact on our community. During the pre-season, Parallel 45 produced a free-to-the-public play-reading series and formalized our partnership with Interlochen Center for the Arts. In order to increase cultural access for all our region's residents, we provided 10 free children's theatre workshops held throughout the Grand Traverse region in spring 2019. In collaboration with organizations such as the Traverse Area District Library, The Great Lakes Children's Museum, area public and private schools, and other nonprofit organizations, we introduced children ages 3-7 to the concept, components, and joy of live theatre. Launching a 2019 summer season in rotating repertory allowed us to produce multiple plays over the course of the summer utilizing one group of professional actors, directors, designers and technicians, alternating performances daily. In partnership with Grand Traverse County Parks & Recreation, the little-used Civic Center amphitheater was transformed into an immersive performance space, with professional lighting and sound, as well as cover for both artists and audience. Theatre professionals traveled from as far away as London and as close as Traverse City to create world-class programming for our community of visiting, seasonal, and year-round residents. More than 3,000 patrons attended summer 2019 productions. Additionally, this new model allowed for enhanced youth and educational offerings, training the next generation of performing arts leaders via a robust apprentice and internship program, the first in our region, and producing a nationally-acclaimed piece of Theatre for Young Audiences.
